ISM-B.b. – These states multiply the BCSO by 150%, multiply each parent’s share by his or her *own* parenting time, and subtract the result from their shares.

ISM-B.c. – Virginia is an outlier variable within Category B.

ISM-C – These states subtract from the noncustodial parent’s BCSO a parenting time credit.

ISM-D – Maine is an outlier that considers an initial 150% multiplier but parenting time is not considered.
