Form C-56

Title 12, Chapter 19, Article 2, Code of Alabama 1975, generally governs the amount and manner of distribution of docket fees which shall be assessed and collected in district and circuit courts throughout the state. The docket fees are uniform throughout the state, except in those counties where additional court costs are authorized by local act. This chart outlines the docket fees and other fees and monies authorized by the statute to be collected. The distribution of the fees as required by the statute is set forth beside each fee.
