SUMMARY

**ECONOMIST, CHILD COST AND CHILD
SUPPORT GUIDELINES EXPERT**

R. Mark Rogers is an economic consultant, with expertise in forensic economics, corporate and government applications. He has been recognized as an expert on child costs as related to family law issues. Previously, as a 19-year veteran economist for the Federal Reserve Bank of Atlanta, Rogers became an expert in analysis of economic data and indicators and in economic forecasting. He recently was Senior U.S. economist for Econoday, Lafayette, CA. He is the author of the *Handbook of Key Economic Indicators, Second Edition* (McGraw-Hill Professional Publishing, 1998; Chinese edition, 1999) and the author of *The Complete Idiot's Guide to Economic Indicators* (Alpha Books, 2009). He has lectured nationally on the use and analysis of economic data with the Institute for Professional Education, Arlington, VA. His primary roles at the Atlanta Fed were macroeconomic forecast coordinator for the Macropolicy Group and the supervising economist for the Atlanta Fed's Survey of Southeastern Manufacturing. He has regularly published about analysis of economic conditions and on child costs in legal and economics publications.

Rogers currently is president of Rogers Economics, Inc., Peachtree City, Georgia, and is an economist specializing in forensic economics of child support cases as well as personal injury and related cases. Rogers also is an adjunct instructor of economics and of business statistics for Clayton State University, Morrow, Georgia.

Regarding child support issues, Rogers began applying his economic expertise in public service as a governor's appointee to the Georgia Commission on Child Support, 1998, and was the commission's only member economist. In this role, Rogers engaged in economic research regarding the origins and economic foundations of child support guidelines. Currently, he is a member of the Georgia Child Support Commission's low-income study committee and the parenting time study committee.

Rogers' child cost research has included updating child support schedules with standard and alternative methodologies, analysis of tax treatment for custodial and non-custodial parents, and standards of living for custodial and non-custodial parents. Case studies for state guideline reviews have gone into more detailed analysis of the economic impact of numerous factors typically addressed by presumptive guidelines or deviations. He has conducted numerous Georgia Bar approved CLE seminars on applying the Income Shares child support guidelines.

Rogers has been qualified as an expert on child costs and related income analysis for custodial and non-custodial parents, before Georgia Superior Court. Rogers has qualified and testified before Superior Court in Atkinson, Berrien, Carroll, Chatham, Cherokee, Clarke, Clayton, Cobb, Coweta, Dekalb, Douglas, Forsyth, Fulton, Gwinnett, Laurens, Lee, Rockdale, and Walton Counties, in Georgia Administrative Court Paulding County, Georgia, and in Juvenile Courts of Gwinnett and Pickens Counties.

Rogers has testified as an expert witness in Florida, Georgia, Indiana, Maryland, Michigan, Minnesota, Missouri, New Hampshire, New Mexico, North Carolina, Ohio, Texas, Virginia, Wisconsin, and Wyoming. Rogers has consulted on child cost issues for clients in Alabama, Florida, Georgia, Illinois, Indiana, Kentucky, Maryland, Massachusetts, Michigan, Minnesota, Missouri, Montana, Nebraska, New Hampshire, New Mexico, New York, North Carolina, Ohio, Tennessee, Texas, Virginia, Washington State, Wisconsin, and Wyoming.

Rogers has testified on child support issues before legislative committees in Georgia, Minnesota, Texas, and Virginia and by invitation before the U.S. Congress. He has presented to child support review commissions in Alabama, Georgia, Massachusetts, Minnesota, North Carolina, Ohio, Tennessee, and Virginia.
